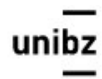

According to Italian tax law, if your fee will be paid by an **Italian Public Institution**, the invoice needs to be sent directly to the institution paying the fee. In order for us to do so, you’ll be asked to provide some more information, namely the Codice Univoco Ufficio (CUU) and the date and number of your order (buono d’ordine). In case you’re not sure, please refer to your administration; they’ll provide you with the needed codes. Once you’ve inserted all the data, you’re done and no further payment steps will be necessary on your behalf.

If you have chosen "private person" or "company, institution or organization" resident in Italy (but NOT a public institution), you'll be redirected to this page, which will be shown for about 5 seconds. Please be patient and wait until you will directed to the next page.

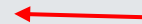
